ORDINANCE NO. 2022 – 387

AN ORDINANCE TEMPORARILY SUSPENDING THE PAYMENT OF FARE MATRIX FOR MOTORCYCLES-FOR-HIRE (MCH) OPERATING IN THE MUNICIPALITY OF OTON AS STIPULATED IN SECTION 3 OF MUNICIPAL ORDINANCE NO. 2022 – 386 DUE TO THE ESCALATION OF FUEL PRICES.

As Requested by the Local Chief Executive, **ON MOTION** of the Chair, Committee on Legal Affairs, Human Rights and Good Governance Hon. Vanessa T. Salinas which was duly seconded by Hon. Lee C. Alison

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. RATIONALE. The Municipality of Oton, Iloilo is now implementing the approved Ordinance no. 2022-386 **“AN ORDINANCE FIXING THE NEW FARE RATE OF MOTORCYCLE-FOR-HIRE OPERATING IN THE MUNICIPALITY OF OTON, ILOILO AMENDING ORDINANCE 2018 – 333.**

“SECTION 3 of Ordinance No. 2022 – 286 ISSUANCE OF FARE MATRIX: The Oton Municipal Franchising and Regulatory Board shall issue a uniform Fare Matrix to all MCH in the Municipality of Oton with the corresponding fee as prescribed in the existing Revenue Code of the Municipality. All Drivers and/or Operators of MCH units shall secure a new Fare Matrix from the OMFRB and shall display it in every unit visible to the commuters. Failure to secure a new fare matrix, the MCH cannot implement the fare increase.”

With the continuous increase of fuel cost and the country is still experiencing COVID 19 Pandemic, the Local Chief Executive of this Municipality requested the Sangguniang Bayan to temporarily suspend the payment of fee (s) in the issuance of Fare Matrix to all MCH as prescribed in the Revenue Code of the Municipality and embodied in Section 3 of Ordinance no. 2022-386.

SECTION 2. AMENDATORY CLAUSE. Section 3 of Ordinance no. 2022-386 on the payment of fees in the issuance of Fare Matrix to all MCH shall be temporarily suspended. The MCH drivers/ operators shall still secure the copy of the Fare Matrix before the OMFRB without payment of prescribed fees.

SECTION 3. ADMINISTRATIVE CLAUSE. The Office of the Business Permit and Licensing, Municipal Treasurer and OMFRB shall be responsible in the implementation of this Ordinance.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval subject to publication based on Section 59 (c) of the Local Government Code of 1991.

SECTION 5. REPEALING CLAUSE. All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby modified accordingly until this ordinance is repealed.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.

SECTION 7. COPIES. This Ordinance shall be furnished to the Office of the Mayor; MTO, MBO, Acctg, BPLO, OMFRB, OFTODA, Oton PNP, MDRRMO-TMTF, Liga ng mga Barangay, and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
