**ORDINANCE NO. 2022 – 392**

**AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 2017-312, ENTITLED “AN ORDINANCE GOVERNING THE GRANT OF FINANCIAL ASSISTANCE IN THE MUNICIPALITY OF OTON, ILOILO AND PRESCRIBING GUIDELINES THEREOF.”**

**AS REQUESTED** by the Local Chief Executive, **ON MOTION** of Hon. Dennis Q. Geroche, Chair of the Committee on Social Welfare, Community Development, CSOs and Cooperative together with his members: Hon. Rodolfo Z. Alconga, Jr. and Hon. Ella Mae S. Yeoh which was duly seconded by Hon. Ma. Lorna T. Geonigo,

**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, that:

**SECTION 1. RATIONALE.** In the light of prevailing circumstances where the cost of living and dying has risen tremendously, the Local Chief Executive has acknowledged the cogent need to adjust the financial assistance of the LGU-Oton to its constituents in dire need or in crisis situation, thus, this Sanggunian has joined the LCE to increase the amount specified on the Burial Assistance and Food and Non-Food Assistance so as to cushion the effects of inflation to the marginalized sector of society.

**SECTION 2. AMENDATORY CLAUSE – Section 3 (c) and (d) of M.O. # 2017-312 is hereby amended into** (The underlined items are the amendments thereto):

**Section 3. Regulated Acts**

1. The beneficiaries of AICS may receive financial assistance but not limited to:
  - c. Burial Assistance – this will include funeral costs and other related expenses, the amount that can be availed from P5,000.00 or higher upon the discretion of the LCE but not to exceed P10,000.00.
  - d. Food and Non-Food Assistance are assessed to be in need of such for at least one & half day to three days. The amount that can be availed is P1,000.00 – P2,000.00 pesos only

**SECTION 3. REPEALING CLAUSE.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.

**SECTION 5. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.

**SECTION 6. COPIES.** This Ordinance shall be furnished to the Office of the Mayor; MBO; MTO; Actg. Office; MSWDO; and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.




