**ORDINANCE NO. 2022 - 396**

**AN ORDINANCE AMENDING ORDINANCE NO. 2022-382 ENTITLED: AN ORDINANCE DECLARING THE OTON TRICYCLE TERMINAL AS TEMPORARY PUBLIC MARKET TO ACCOMMODATE THE VENDORS AFFECTED BY FIRE INCIDENT AT THE OTON PUBLIC MARKET.**


**AS PROPOSED BY** Vice Mayor Jose Neil P. Olivares, **ON MOTION** of Hon. Jimmy R. Olivares which was duly seconded by Hon. Dennis Q. Geroche;

**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, that:

- SECTION 1. RATIONALE OF AMENDMENT** – A Multi-purpose Building (Bagsakan) Project of Representative Janette L. Garin will be constructed in an open space beside the Oton Tricycle Terminal and temporary market stalls.
- SECTION 2. AMENDATORY CLAUSE – SECTION 3.** The open space of the Tricycle Terminal at the Eastern Section, containing an area of more or less 540 square meters shall be used as site of a Multi-purpose Building (Bagsakan)
- SECTION 3.** Sections 3 to 7 of Municipal Ordinance 2022-382 shall be arranged chronologically.
- SECTION 4. REPEALING CLAUSE.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
- SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.
- SECTION 6. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.
- SECTION 7. COPIES.** This Ordinance shall be furnished to the Office of the Mayor; MBO, MTO, Acctg., Oton PNP, BFP, MDRRMO, MOBO, MEO, MEEDO, MPDC, Zoning Office, Municipal Administrator, Municipal Legal Officer and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.


