**ORDINANCE NO. 2023 – 408**

**AN ORDINANCE AMENDING SECTION 4 OF MUNICIPAL ORDINANCE NO. 2019-343, ENTITLED: AN ORDINANCE ESTABLISHING THE OFW HELP DESK IN THE MUNICIPALITY OF OTON, ILOILO.**

**AS REQUESTED BY** the Local Chief Executive, **ON MOTION** of Hon. Dennis Q. Geroche Chair, Committee on Social Services, which was seconded by Rodolfo Zurita Alconga, Jr., **BE IT ORDAINED** that;

**Section 1. The Ordinance 2019-343 needs amendment by adding a provision on the person to man the OFW Help Desk of the Municipality.**

**Section 2 . Amendatory Clause. The underlined item shall be the amendment to Section 4 of Municipal Ordinance no 2019-343.**

**“SECTION 4. Creation of OFW Help Desk.** There shall be created an OFW Help Desk to be a one–stop–shop OFW Help Desk which shall coordinate the initiative in addressing the psycho–social, moral, economic, legal and spiritual concerns of the Ogtonganon OFWs and their families. The Local Chief Executive shall appoint a focal person (either from the rank of Regular Employees (in concurrent capacity), Job Order or Contract of Service personnel from the Office of the Municipal Social Welfare and Development or other Offices at the discretion of the Local Chief Executive to man the OFW Help Desk.”

**SECTION 3. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.

**SECTION 4 REPEALING CLAUSE.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.



