**ORDINANCE NO. 2023 – 409**

**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2023 – 405 ENTITLED: AN ORDINANCE PRESCRIBING THE CLASSIFICATION AND REGULATING THE REGISTRATION AND OPERATION OF ELECTRIC OR MANUAL PUBLIC AND PRIVATE TRISIKAD IN THE MUNICIPALITY OF OTON, ILOILO.**

**AS PROPOSED BY** Vice Mayor Jose Neil P. Olivares, **ON MOTION** of Hon. Jimmy R. Olivares which was duly seconded by Hon. Grace Marie Escanlar – Cruz,  
**BE IT ORDAINED** by the Sangguniang Bayan ng Oton, Iloilo, that:

**SECTION 1. AMENDMENTS.**

- a. Paragraph A, Section 8 shall be amended into: A. Franchise – owners of EPT, before operation shall apply for a franchise with the Sangguniang Bayan ng Oton (Delete: with franchise number upon passage of a Resolution). The franchise with franchise number is embodied in the PTOP issued by the SB through the Vice Mayor.
- b. Paragraph I of Section 8 (Administrative Clause) shall be: an EPT owner / operator shall be allowed to register a maximum of five (5) EPT units under his name. (new provision)
- c. Sub-paragraph (I) of paragraph (G) of Section 8 (Administrative Clause) shall be:
  - 1. Owner and driver of EPT shall undergo a Seminar and/or examination at the Traffic Management Unit of MDRRMO (new provision); adjustment of numbering follows (2 to 12)
- d. Paragraph C of Section 8 shall be amended into:
  - c. The office of the Municipal Administrator shall issue white plates for public utility Trisikad.

**SECTION 2. REPEALING CLAUSE.** — All ordinances contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly.


**SECTION 3. SEPARABILITY CLAUSE.** — If any part or provision of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity and effectivity of the other parts or provisions hereof.


**SECTION 4. EFFECTIVITY CLAUSE.** This amending ordinance shall take effect upon approval of the Local Chief Executive.




