ORDINANCE NO. 2023 – 436

DECLARING THE FIRST WEEK OF SEPTEMBER OF EVERY YEAR AS PHILIPPINE COUNCILORS WEEK IN THE MUNICIPALITY OF OTON, ILOILO AND PROVIDING FUNDS THEREFOR.

AS PROPOSED and **ON MOTION** by Hon. Rodolfo Z. Alconga Jr. and **DULY SECONDED** By Hon. Ma. Lorna T. Geonigo;

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. INTRODUCTION.

The Philippine Councilors League (PCL) is a local government association composed of policy-makers all over the country, recognized by the Department of Interior and Local Government (DILG) on September 3, 1990, and subsequently registered with the Securities and Exchange Commission (SEC) on September 17, 1990;

RA 7160, otherwise known as the Local Government Code of 1991, recognizes, among others, the existence of the Federation of elective officials such as the Philippine Councilors League;

Article XV, Section 1 of the PCL Constitution and By-Laws states that there shall be a Provincial Federation in each province and a city chapter in each Independent Component City (ICC), and Section 8 states further that the Provincial Federation shall coordinate programs, plans and activities of the Philippine Councilors League on the provincial level;

Pursuant to Proclamation No. 212, s-1993, the first week of September of every year is declared as Philippine Councilors Week in celebration of its founding anniversary on September 7, 1990;

SECTION 2. TITLE.

This Ordinance shall be known as “SEMANA SANG MGA KONSEHAL SANG OTON”, a week-long celebration of Philippine Councilors League in the Municipality of Oton on the first week of September of every year.

SECTION 3. OBJECTIVES. The PCL- Oton Week celebration aims to:

1. strengthen the rapport, camaraderie and brotherhood among local legislators in the municipality;
2. provide an avenue and platform for local legislators to discuss current issues and concerns through effective legislation;
3. formulate, implement and coordinate programs, projects and activities beneficial to the members of the League and/or the general welfare of the people; and,
4. undertake fund raising projects and activities to support PCL programs and objectives.

SECTION 4. PROGRAMS AND ACTIVITIES.

The Sangguniang Bayan ng Oton with the Municipal Board Designate, shall spearhead the planning and implementation of relevant programs and activities including, but not limited to the following:

1. Continuing Local Legislative Education Program (CLLEP) for Members of the Sangguniang Bayan and/or Sangguniang Barangays;
2. Sports Olympics;
3. Team Building;
4. Fellowship and Socials;
5. Community Outreach Program;
6. Benchmarking Activities;
7. Coordinate with the PCL Provincial League on the Plans, Programs and Activities of the League.

The week-long activities shall be carried through the succeeding months leading to the Annual Year- End Assessment Program scheduled on December of the year.

SECTION 5. SOURCE OF FUND. To carry out the purposes of this Ordinance, the Office of the Vice Mayor and the Sangguniang Bayan shall allocate funds based on the Activity Design Proposal from its annual or supplemental Appropriation (**Support Fund for Sangguniang Bayan Programs**) necessary for the implementation of this Ordinance. The Plans, Programs and Activities (PPAs) therein shall be included in the Annual / Supplemental Investment Program of the Municipality.

SECTION 6. EFFECTIVITY CLAUSE. This Ordinance having no penal provision shall take effect immediately upon approval of the Local Chief Executive.


SECTION 7. SEPARABILITY CLAUSE. If any provision(s) of this. Ordinance be declared to be invalid by competent authority, the remaining provisions hereof not affected thereby shall continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE. All ordinances or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


