ORDINANCE NO. 2024 – 441

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2001-96, AN ORDINANCE DECLARING OTON AS MUNICIPALITY OF CHARACTER AND ENACTING THE CHARACTER DEVELOPMENT CODE.

AS PROPOSED by Vice Mayor Jose Neil P. Olivares **ON MOTION** of the Committee on Youth and Sports Development composed by Hon. Hyacinth C. Gardose, Hon. Dennis Q. Geroche and Hon. Rodolfo Z. Alconga, Jr. which was duly seconded by Hon. Lee Alison - Bretaña

BE IT ORDAINED by the Sangguniang Bayan ng Oton, Iloilo, that:
SECTION 1. AMENDATORY CLAUSE

A. Section 2, Article I of Municipal Ordinance No. 2001-96 shall be amended into:

DEFINITION OF TERMS:

- m. **Loyalty (Mainunungon)** – faithfulness to something bound by pledge or duty.
- n. **Tolerance (Mahinangpanon)** – willingness to accept feelings, habits or beliefs that are different from your own.
- o. **Contentment (Kontento)** – state of being satisfied, at peace, and emotionally fulfilled with what one has.
- p. **Compassion (Maluluy-on)** –recognizing the suffering of others and taking action to help.
- q. **Enthusiasm (Makunyagon)** – energetic to a particular cause with a desire to be involved in it.
- r. **Honor (Dungganon)** – showing one’s worth that brings respect.
- s. **Determination (Pursigido)** – an act of deciding definitely and firmly.
- t. **Creativity (Mapahituon)** – having or showing an ability to make new things or think of new ideas.
- u. **Sensitivity (Sensitibo)** – understanding what other people feel and need.
- v. **Punctuality (Temprano)** – being prompt or doing something at the expected time.
- w. **Justice (Matarong)** – being just, fair and righteous in his dealings.
- x. **Sincerity (Bunayag ang Tagipusuon)** – being genuine in intentions and actions.

B. Section 3, Article II of the same ordinance shall be amended into:

 mapinasensyahon/ mahinangpanon,
 mapinasalamaton/kontento,
 mapinatawaron/ maluluy-on,
 responsable/makunyagon,
 matinlo/dungganon,
 masaligan/pursigido,
 mapisan/mapahituon
 disiplinado/sensitibo,
 may inisyatibo/ temprano,
 mapainubuson/matarong kag
 maalwan/bunayag ang tagipusuon.
 Buligan ako sang Dios.

C. Section 1, Article IV of the same ordinance shall be amended into:

Section 1. The Two sets of 12-character traits that will be alternately observed and developed per year shall be:

- a. January – Truthfulness/Loyalty
- b. February – Patience/Tolerance
- c. March – Gratefulness/Contentment
- d. April – Forgiveness/Compassion
- e. May – Responsibility/Enthusiasm
- f. June – Cleanliness/ Honor
- g. July – Dependability/Determination
- h. August – Hardwork/Creativity
- i. September – Discipline/Sensitivity
- j. October – Initiative/Punctuality
- k. November – Humility/Justice
- l. December – Generosity/Sincerity

SECTION 2. SEPARABILITY CLAUSE. If any provision of this Ordinance be held invalid, the provision/s, not otherwise affected thereby shall remain valid and effective.


SECTION 3. REPEALING CLAUSE. All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed, amended and/or modified accordingly.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval of the Local Chief Executive.


