ORDINANCE NO. 2024 – 442

AN ORDINANCE AMENDING SECTION 14 (A) OF ORDINANCE NO. 2023 – 426 “AN ORDINANCE IMPOSING ZERO OPEN DEFECATION IN THE MUNICIPALITY OF OTON, ILOILO.”

AS ADVISED by the Sangguniang Panlalawigan of Iloilo **ON MOTION** of Hon. Jimmy R. Olivares, Chair Committee on Health and Sanitation, together with Hon. Ernesto C. Ticao and Hon. Hyacinth C. Gardose which was duly seconded by Hon. Ma. Lorna T. Geonigo

BE IT ORDAINED by the Sangguniang Bayan ng Oton, Iloilo, that:

SECTION 1. AMENDATORY CLAUSE

Pursuant To Sangguniang Panlalawigan **RESOLUTION NO. 2023 - 985, ENTITLED: “RESOLUTION ADOPTING COMMITTEE ON HEALTH AND SANITATION AND APPROVING ITS RECOMMENDATION REMANDING ORDINANCE NO. 2023-426 OF THE MUNICIPALITY OF OTON, PROVINCE OF ILOILO, ENTITLED: AN ORDINANCE IMPOSING ZERO OPEN DEFECATION IN THE MUNICIPALITY OF OTON, ILOILO FOR APPROPRIATE ACTION WITHOUT PREJUDICE TO ITS RESUBMISSION TO THIS AUGUST BODY, Section 14 (A) of Municipal Ordinance No. 2023 - 426 shall be amended into:**

A. The Head of the Family of a Household With No Sanitary Toilet shall be meted a Fine of P500.00 or Imprisonment of One(1) Day, or Both Fine And Imprisonment at the Discretion of the Court for second and Succeeding Offenses.

SECTION 2. SEPARABILITY CLAUSE. If any portion or provision of this Ordinance is declared void or unconstitutional, the remaining portion thereof shall not be affected thereby and shall remain in full force and effect.

SECTION 3. REPEALING CLAUSE. All ordinances, or parts thereof which are inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect at the end of its posting for a minimum period of three (3) consecutive weeks or on the day following its publication in a newspaper of general circulation within the territorial jurisdiction of Municipalities, whichever occurs later.

SECTION 6. COPIES. This Ordinance shall be furnished to the Office of the Mayor; MPDC, MHO, MENRO, Municipal Administrator, Legal Officer, Liga ng mga Barangay, 37 barangays, MLGOO, BHW Association, MSWDO, DOH, Provincial Health Office DOH, Regional Office MACO and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
