**ORDINANCE NO. 2024 – 448**

**AMENDING THE POSITION TITLES PARTICULARLY IN SECTION 2 IN ORDINANCE NO. 2021-378 OF THE MUNICIPALITY OF OTON, ILOILO.**

**AS REQUESTED BY** the Local Chief Executive, **ON MOTION** of Hon. Ernesto C. Ticao, Chair of the Committee on Legal Affairs, Human Rights and Good Governance together with Hon. Vanessa T. Salinas and Hon. Paul M. Buenafe which was duly seconded by Hon. Dennis Q. Geroche,

**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, that:

**SECTION 1. RATIONALE:** The Local Chief Executive requested for the amendments on the position titles as embodied in Ordinance 2021-378 entitled “AN ORDINANCE CREATING ADDITIONAL OFFICES AND PLANTILLA POSITIONS IN DIFFERENT OFFICES IN THE MUNICIPALITY OF OTON, ILOILO THEREBY AMENDING ORDINANCE NO. 2009-18 (219) “AN ORDINANCE APPROVING THE RE-ORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND PLANTILLA OF PERSONNEL AND THE CREATION OF THE MUNICIPAL ECONOMIC ENTERPRISE DEVELOPMENT OFFICE (MEEDO) OF THE MUNICIPALITY OF OTON, ILOILO” AS AMENDED”. There is a need to amend the position titles of some plantilla positions in Section 2 (Amendatory Clause) of Ordinance 2021-378, to conform with the new IOS (Index of Occupational Services, Position Titles and Salary Grade in the LGU (IOS-LGU) CY 2021 Edition as per Local Budget Circular No. 137 dated July 13, 2021 of the DBM.

**SECTION 2. AMENDATORY CLAUSE:** The following underlined items shall be the amendments to the existing Position Titles embodied in Section 2 of Municipal Ordinance 2021-378 Section:

**H. MUNICIPAL CIVIL REGISTRAR’S OFFICE**

Liaison Aide SG 4 shall be amended to Administrative Aide IV (Bookbinder II)

**J. MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE**

Municipal Social Development Officer shall be amended to MGDH 1 (Municipal Social Welfare and Development Officer).

**M. MUNICIPAL AGRICULTURE AND COOPERATIVE OFFICE**

Aquaculture Technologist shall be amended to Aquacultural Technologist

**SECTION 3. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.

**SECTION 4. REPEALING CLAUSE.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby amended/ modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.

**SECTION 6. COPIES.** This Ordinance shall be furnished to the Office of the Mayor; HRMO, MPDC, MBO, Accounting, MTO, MSWDO, MACO, Mun. Administrator, and other Offices in the LGU, CSC RO VI, and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
