**ORDINANCE NO. 2024 – 451**  
**AN ORDINANCE AMENDING ORDINANCE NO. 2021-378 PARTICULARLY ON SECTION 3 (G) AMENDING THE POSITION TITLE OF THE MUNICIPAL TREASURER.**

**AS REQUESTED BY** the Local Chief Executive, **ON MOTION** of Hon. Ernesto C. Ticao, Chair of the Committee on Legal Affairs, Human Rights and Good Governance together with Hon. Vanessa T. Salinas and Hon. Paul M. Buenafe which was duly seconded by Hon. Dennis Q. Geroche,

**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, that:

**SECTION 1. RATIONALE:** The Local Chief Executive requested for the amendment on the position title of the Municipal Treasurer as embodied in Ordinance 2021-378 entitled **“AN ORDINANCE CREATING ADDITIONAL OFFICES AND PLANTILLA POSITIONS IN DIFFERENT OFFICES IN THE MUNICIPALITY OF OTON, ILOILO THEREBY AMENDING ORDINANCE NO. 2009-18 (219) “AN ORDINANCE APPROVING THE RE-ORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND PLANTILLA OF PERSONNEL AND THE CREATION OF THE MUNICIPAL ECONOMIC ENTERPRISE DEVELOPMENT OFFICE (MEEDO) OF THE MUNICIPALITY OF OTON, ILOILO” AS AMENDED”**.

There is a need to amend the position title to conform with the new IOS (Index of Occupational Services, Position Titles and Salary Grade in the LGU (IOS-LGU) CY 2021 Edition as per Local Budget Circular No. 137 dated July 13, 2021 of the DBM.

**SECTION 2. AMENDATORY CLAUSE:** The underlined phrases shall be the amendment to the existing Position Title embodied in Municipal Ordinance 2021-378- Section 3 (G):

**G. Municipal Treasurer’s Office**

Municipal Treasurer shall be amended into **MGDH-I (Municipal Treasurer)**

**SECTION 3. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.

**SECTION 4. REPEALING CLAUSE.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby amended/ modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.

**SECTION 6. COPIES.** This Ordinance shall be furnished to the Office of the Mayor; HRMO, MPDC, MBO, Accounting, MTO, Mun. Administrator, and other Offices in the LGU, CSC RO VI, and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
