ORDINANCE NO. 2025 – 474

**AN ORDINANCE AMENDING SECTION 3(A) AND 4(A) OF ORDINANCE NO. 2025-473
“ORDINANCE TEMPORARILY CLOSING PORTIONS OF NATIONAL AND MUNICIPAL
ROADS/ STREETS IN RELATION TO THE HOSTING OF THE FIRST CONGRESSIONAL
DISTRICT SPORTS ASSOCIATION (1ST CDSA) MEET 2025”.**

AS REQUESTED by The Local Chief Executive, **ON MOTION** of Hon. Rodolfo Z. Alconga, Jr. which was duly seconded by Hon. Hyacinth C. Gardose,

BE IT ORDAINED by the Sangguniang Bayan ng Oton in session assembled, that:

SECTION 1. AMENDATORY CLAUSE:

SECTION 3. REGULATORY CLAUSE:

The following roads / streets in the Municipality of Oton shall be closed on the following dates:

A. **January 20 and January 22, 2025** – 1:00PM to 6: 00PM – Mabini St; Rizal St; General Luna St; J.C. Zulueta St; Paterno St and Planta St. - shall be used for Rehearsal and Opening Parade.

SECTION 4. ADMINISTRATIVE CLAUSE

A) **Temporary Route** – Southern bound private and public vehicles shall pass through Diversion Road, San Jose Road, Bangga Fabian, right turn to C.M. Recto St., left turn to Burgos St. and Benedicto St. going to Gaisano Capital Oton; while those bound to Iloilo City shall pass through J.C. Zulueta Street, left turn to MH del Pilar St, right turn to F.C. Zulueta St, left turn to General Luna St., right turn to C.M. Recto St (at the back of the plaza), turn left to Batiano Bridge going to Barangay San Antonio.

SECTION 2. REPEALING CLAUSE – All ordinances inconsistent with this ordinance are hereby repealed or amended accordingly.

SECTION 3. SEPARABILITY CLAUSE – If any provision of this ordinance is declared unconstitutional or inoperative, the other provisions not so declared shall remain in force and effect.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval of the Local Chief Executive.

SECTION 5. COPIES. This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; DEPED OTON, TMTF- MDRRMO; Tourism Office, Information Officer; Barangays, Poblacion West, Poblacion South, Poblacion East and Poblacion North, Alegre, Oton; OFTODA; SOJODA, ANHAWAN PUV Organization, Liga ng mga Barangay, and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
