**RESOLUTION RECOGNIZING THE THIRTY NINE (39) YEARS OF GOVERNMENT SERVICE OF EMMA VILLANUEVA HARO, RETIRED EFFECTIVE JANUARY 1, 2022 AS MUNICIPAL AGRICULTURAL OFFICER (DEPARTMENT HEAD) OF THE MUNICIPAL AGRICULTURE AND COOPERATIVE OFFICE OF THE MUNICIPALITY OF OTON, ILOILO.**

**WHEREAS**, Emma Villanueva Haro born on October 10, 1958, retired at the age of 63 effective January 1, 2022 from her position as Municipal Agricultural Officer, Office of the Municipal Agriculture and Cooperative of the LGU – Oton;

**WHEREAS**, she is married to Domingo Icoy Haro, a retired employee of the LGU Oton and they were blessed with 2 children namely Aubrey Ralph and Ma. Allysa Joy;

**WHEREAS**, she graduated from the University of Iloilo with a course of Bachelor of Science in Agriculture in 1980; graduated her Diplome in Agriculture from the University of the Philippines- Los Baños in 1988 and took 18 units in Masters in Agriculture from West Visayas State University; she is a holder of Career Service Sub Professional and Professional Eligibility and License Agriculturist under RA 1080;

**WHEREAS**, she joined the government service in 1982 as FMT Ministry of Agriculture; promoted to Agricultural Farm Technician (AFT) in 1985, Agricultural Production Technician in 1988 of the Department of Agriculture Provincial Office and Agricultural Technologist in 1989; entered the LGU Oton in 1992 as Agricultural Technologist by virtue of EO 503 on Devolution; promoted to Agriculturist II in 2005 and last March 8, 2017 she was promoted to a Department Head Position as Municipal Agricultural Officer until she retired, serving for 30 years in the LGU – Oton and nine (9) years in the DA Provincial Office with a total of Thirty-Nine (39) years of government service;

**WHEREAS**, Emma V. Haro is the Secretary of Horticultural Crop Organization Iloilo Chapter, Agricultural Extension Workers Association, Iloilo and Member of Oton Municipal Government Multi-Purpose Cooperative; a team player, friendly, soft spoken, hardworking and devoted employee of the LGU;




