RESOLUTION AUTHORIZING MAYOR CARINA V. FLORES TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF OTON, ILOILO, A MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPALITY OF OTON, ILOILO AND THE ST. PAUL UNIVERSITY (SPU) ILOILO FOR ITS ON-THE-JOB TRAINING (OJT) PROGRAM.

WHEREAS, the St. Paul University (SPU) Iloilo is offering Bachelor of Science courses wherein the students are required to undergo on-the-job training (OJT) Program as an academic requirement prior to graduation in order to be adequately exposed to actual industrial work situation, thereby augmenting their formal schooling;

WHEREAS, the LGU – Oton has been chosen as the site facility for the on-the-job training (OJT) of the students of St. Paul University (SPU) Iloilo wherein the LGU has the facilities and/or expertise to provide occupational experience to student-trainees to enhance their competence in their chosen field of endeavour as part of its efforts to help Community Development and cultivate pool from which the Office may possibly recruit its needed personnel in the future;

WHEREAS, the students will undergo a preferable length of training of at least two hundred hours (200hrs) and non-intermittent;

WHEREAS, a MOA is needed in order to bind both parties, the LGU-Oton and St. Paul University (SPU) Iloilo, of their duties and responsibilities in the implementation of the On- The- Job Training Program.


