CONTAINING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF TWENTY
NINE (29) BARANGAYS IN THE MUNICIPALITY OF OTON, ILOILO.**

WHEREAS, the Committee on Appropriation rendered Committee Report No. 2022 – 05, dated March 7, 2022 reviewing the Annual Budget of twenty nine (29) barangays based on the review and recommendation of the Municipal Budget Officer;

WHEREAS, the Barangay shall take appropriate steps in implementing the 20% Development Fund, 10% Sangguniang Kabataan Share, 5% Local Disaster Risk Reduction Management Fund shall be in accordance with R.A 10121 and its implementing Rules and regulations.

WHEREAS, that disbursement of the allocation for the Maintenance and other and other operating expenses shall be subject to the usual auditing rules and regulations.

WHEREAS, the Barangay did not exceed the Personal Services limitation mandated by the Local Budget Circular No. 75 and Section 331-B of the Local Government Code but incurring additional Personal Services allocation will exceed the 55% limitation. The Barangay is therefore advised not to incur additional PS Expenditures either by realignment or additional appropriations.

WHEREAS, items of appropriation mainstreamed/subsumed in the General Fund budget that specify Gender and Development (GAD) plans and projects shall be subject to Local Budget Memorandum (LBM) No. 36 dated July 4, 2001 and DBM/NEDA/NCRFW Joint Circular No. 2001-01 dated August 15, 2001.

WHEREAS, the amount appropriated does not exceed the estimates of income.

WHEREAS, obligations/disbursements of this Annual Budget shall not exceed the amount authorized by the Sangguniang Barangay and subject to existing budgeting, accounting and auditing rules and regulations.

WHEREAS, the budget may therefore be considered OPERATIVE as to the date of its effectivity subject to the above conditions.

WHEREAS, compliance with the existing laws, rules and regulations of the Local Government Code of 1991 shall be responsibility of the Punong Barangay concerned.

NOW THEREFORE on motion of Committee on Appropriation composed by Hon. Rodolfo Z. Alconga, Jr., Hon. Anna Rena P. Trespeses, Hon. Vanessa T. Salinas which was duly seconded by Hon. Dennis Q. Geroche, be it

RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan ng Oton, Iloilo to pass this Resolution Declaring Operative the Appropriation Ordinances Containing the Annual Budget for Calendar Year 2022 of Twenty Nine (29) Barangays in the Municipality of Oton, Iloilo.
