RESOLUTION AUTHORIZING HONORABLE MAYOR CARINA V. FLORES TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF OTON, ILOILO A MEMORANDUM OF AGREEMENT (MOA) WITH THE REPRESENTATIVE PEDRO G. TRONO MEMORIAL HOSPITAL FOR THE REFERRAL AGREEMENT TO ENSURE PATIENTS OF THE LIGTAS COVID – 19 CENTER OF OTON WHO NEED HOSPITALIZATION CAN BE TRANSFERRED THROUGH A COORDINATED MEDICAL CARE.

WHEREAS, the Department of Health (DOH) and the Department of the Interior and Local Government (DILG) through a Joint Administrative Order No. 2020 – 0001 dated April 15, 2020 issued Guidelines on Local Isolation and General Treatment Areas for COVID – 19 cases (LIGTAS COVID) and the Community Based Management of Mild COVID – 19 Cases;

WHEREAS, pursuant to DILG Memorandum Circular No. 2020 – 023 entitled: “Amended Guide to Action Against the 2019 Novel Coronavirus Acute Respiratory Disease” recognizes the lead role of Local Government Units (LGUs) in the prevention, mitigation, preparedness for, and containment of the Coronavirus Disease 2019 (COVID – 19) outbreak at the local level;

WHEREAS, DILG Memorandum Circular No. 2020 – 064, entitled: Provincial/ City/ Municipal Special Care Facilities and Isolation Units Amid the COVID – 19 Pandemic”, directs all local chief executives (LCE) to identify government facilities that may be temporarily converted into isolation and quarantine facilities, and to immediately designate and establish their respective COVID – 19 special care facilities, in support of Resolution No. 16 dated March 27, 2020 by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases;

WHEREAS, DOH Department Memorandum No. 2020 – 0108 entitled: Guidelines for Management of Patients with Possible and Confirmed COVID – 19” emphasizes home quarantine for individuals with mild symptoms;

WHEREAS, referral hospitals of LIGTAS COVID Center can either be private or government Level 2 – Level 3 hospitals with service capability for suspected probable or confirmed cases and has a commitment to discharge or transfer all admitted stable non-COVID Patients as prescribed in department Memorandum No. 2020 – 0142 dated March 23, 2020;

WHEREAS, Rep. Pedro G. Trono Memorial District Hospital is a Level 1 District Hospital owned and managed by the Iloilo Provincial Government (IPG);

WHEREAS, the Municipality of Oton and the IPG intend to enter into this patient referral agreement to ensure that patients of the LIGTAS COVID Center of Oton who need hospitalization can be transferred through a coordinated medical care.

NOW THEREFORE on motion of Hon. Grace Marie S. Escanlar – Cruz which was duly seconded by Hon. Vanessa T. Salinas, be it


RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan ng Oton, Iloilo to pass this Resolution Authorizing Honorable Mayor Carina V. Flores to Enter Into and Sign for and in Behalf of the Municipality of Oton, Iloilo a Memorandum of Agreement (MOA) with the Representative Pedro G. Trono Memorial Hospital for the Referral Agreement to Ensure Patients of the Ligtas COVID – 19 Center of Oton Who Need Hospitalization can be Transferred through a Coordinated Medical Care.
