RESOLUTION REQUESTING FOR FUNDS OR TECHNICAL ASSISTANCE FROM THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) FOR THE RESTORATION OF THE SCULPTURES DEPICTING THE DIFFERENT LIVELIHOOD IN OTON IN THE CONCEPT OF “MAN IN HIS ENVIRONMENT” AT THE OTON PUBLIC PLAZA.

WHEREAS, the Public Plaza of Oton, known as the Amphitheatre Green, was once known as one of the most beautiful public plazas in the world during the 24th International Conference of Landscape Architects in 1987;

WHEREAS, the lagoon of the amphitheatre was themed “Man in His Environment” depicting the concept that while the Ogtonganons have different livelihood, they live with their livelihood without damaging the environment;

WHEREAS, with the passage of time since the 1980’s, the sculptures of a fisherman, farmer and blacksmith were vanded and ultimately destroyed;

WHEREAS, a grant from the NCCA for the restoration of the abovementioned sculptures will bring back the genuineness of this world renowned plaza;

NOW THEREFORE, as proposed by Vice Mayor Jose Neil P. Olivares, on motion of the Committee on Culture, History, Arts and Tourism composed by Hon. Antonio Prias Masculino, Hon. Lee C. Alison-Bretaña and Hon. Ma. Lorna T. Geonigo which was duly seconded by Hon. Dennis Q. Geroche, be it


