RESOLUTION OF COMMENDATION TO THE OTON MUNICIPAL POLICE STATION HEADED BY PMAJ. FERNAND L. LIMBUNGAN FOR THE SUCCESSFUL ARREST OF THE TOP 2 MOST WANTED PERSON IN THE MUNICIPAL LEVEL WITH WARRANT OF ARREST FOR 4 COUNTS OF SEXUAL ABUSE (THROUGH SEXUAL INTERCOURSE) UNDER SECTION 5(B) OF REPUBLIC ACT 7610.

WHEREAS, last July 19, 2022 at around 10:30 in the evening at Barangay San Nicolas, Oton, Iloilo, the members of Oton Municipal Police Station led by PMAJ Fernand L. Limbungan, OIC, together with the RID6, 1st IPFMC, and IBSO, VFU, AKG arrested the person of Samuel Medel Y Acuesta, male, top 2 Most Wanted Person (Municipal Level) with warrant of arrest under Criminal Case # 22-87692, 22-87693, 22-87694, 22-87695 for Sexual Abuse (Through Sexual Intercourse) under Section 5 (B) of RA 7610, 4 counts issued by Hon. Regina Centenera Galang-Guarin of RTC 6 Branch 30, Iloilo City;

WHEREAS, the Operating team was composed by 32 OMPS Personnel, 4 Augmented personnel from RID6, 3 PNP personnel from 1st IPMFC and One (1) personnel from IBSO, VFU, AKG;

WHEREAS, the coordinated effort of these police officers from different units specifically the personnel of the OMPS is a manifestation of PNP's commitment to enforce the law, uphold the justice system and serve the community to attain peace and order and safety; said accomplishment is worthy of emulation and commendation
