**WHEREAS**, Section 17 of the Local Government Code of 1991 provides that Local Government units are tasked to provide basic social services in their localities including relief assistance in times of calamities;

**WHEREAS**, the National Food Authority (NFA) is a government agency charged with, among others, in ensuring the nation’s adequate supply and distribution of grains;

**WHEREAS**, the Municipality of Oton will purchase rice from NFA to provide immediate assistance to the constituents especially those indigents and vulnerable during the state of calamity, disasters or during the state of Pandemic;

**WHEREAS**, the LGU Oton will utilize any available funds intended thereto from the 2022 Annual Budget and other services for the purchase of rice with the NFA.


