**WHEREAS**, his first employment was as Secretary of the late Judge Manuel Roa;

**WHEREAS**, he joined the government service as Rural Development Worker (RDW) of the Presidential Assistance for Community Development (PACD) now the DILG;

**WHEREAS**, he had been assigned to South Cotabato, Negros Occidental, Capiz, Antique and Iloilo when the PACD became the Department of Local Government and Community Development (DLGCD);

**WHEREAS**, in 1971 Mr. Luis N. Bravo was assigned to his hometown Oton as Municipal Development Officer;

**WHEREAS**, in 1977 the DLGCD became the Ministry of Local Government and Community Development (MLGCD), thus, Mr. Bravo became the MLGCD Officer of Oton, Iloilo;

**WHEREAS**, during the transition of government in 1986 after EDSA People power Revolution, he effectively assisted the then OIC-Mayor Felix L. Flores and the appointed members of the Sangguniang Bayan;

**WHEREAS**, after serving the government ably and productively for 43 years, he retired in 1992 as Local Government Officer V of the DILG;

**WHEREAS**, he was a very loving husband and father respectively to his wife Dolores Bersamin and four children: Vincent, Voltaire, Veda and Luisito, and a supportive and caring brother and uncle to his 2 siblings and nephews and nieces respectively;

**WHEREAS**, he lived his 90-year existence to the fullest by serving his fellowmen, and his faithfulness and dedication to civil service are worthy of emulation by today's civil servants;




