RESOLUTION NO. 2022 – 201

RESOLUTION AUTHORIZING MAYOR SOFRONIO L. FUSIN, JR. TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF OTON, ILOILO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) FOR THE NFA RICE SALES PROGRAM.

WHEREAS, the NFA pursuant to Republic Act No. 11203 is the government agency mandated to maintain an optional level of rice inventory at any given time to be used for emergency situations and to sustain the disaster-relief programs of the government during natural or manmade calamities;

WHEREAS, under the Local Government Code (LGC), the local government units (LGUs) are vested with authority to discharge the functions and responsibilities of national agencies and offices devolved to them; and have been tasked in providing basic services at all times particularly in times of calamities;

WHEREAS, the local government units (LGUs) in order to provide immediate assistance to their constituents, have requested the NFA to allow them to purchase rice on cash and credit for relief distribution operations/ stockpiling/ prepositioning as part of their disaster preparedness and other needs of their various projects/ programs;

WHEREAS, the LGUs are authorized to set aside five percent (5%) of the Internal Revenue Allotment (IRA) or any amount from estimated revenue for unforeseen expenditures arising from the occurrence of calamities, provided that such appropriation shall be used only in the area affected by a disaster or calamity;

WHEREAS, the LGUs are requested to set aside an amount equivalent to twenty percent (20%) of the estimated revenue from regular sources as annual lump sum appropriation for Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk management activities;

WHEREAS, the NFA, cognizant of the needs of the people in times of emergency/ calamity as part of the disaster preparedness of the government acceded to the request of the LGU–Oton to purchase rice on cash and credit basis subject to the agreed terms and conditions on the MOA.

WHEREAS, this Sanggunian authorizes Mayor Sofronio I. Fusin, Jr. to enter into a Rice Sales Memorandum of Agreement with the National Food Authority to purchase rice from NFA based on the agreement;

NOW THEREFORE on motion of Hon. Lee Alison-Bretaña which was duly seconded by Hon. Jimmy R. Olivares, be it


RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan ng Oton, Iloilo to pass this Resolution Authorizing Mayor Sofronio L. Fusin, Jr. to Enter into and sign for and in behalf of the Municipality of Oton, Iloilo a Memorandum of Agreement (MOA) with the National Food Authority (NFA) for the NFA rice sales program.

RESOLVED FURTHER to furnish copies of this Resolution to the Office of the Mayor; NFA; MBO; MTO; Actg. Office; MPDC; MSWDO; MDRRMO and MACO for information and guidance.
