RESOLUTION NO. 2022- 207

RESOLUTION DECLARING OPERATIVE THE APPROPRIATION ORDINANCES OF FIVE (5) BARANGAYS: CABANBANAN, SAMBALUDAN, STA. RITA, STA. MONICA AND BATUAN ILAYA, OTON CONTAINING THEIR RESPECTIVE SUPPLEMENTAL BUDGETS FOR THE CURRENT YEAR.

WHEREAS, the Committee on Appropriations rendered its Committee Report No. 2022 – 33 after reviewing the Appropriation Ordinances of the following Barangays:

a) Appropriation Ordinance No. 2022 – 001 of Barangay Cabanbanan, entitled: “An Appropriation Ordinance Approving Supplemental Budget No. 2022 – 01 and Appropriating the Amount of One Hundred Nine Thousand Six Hundred Ninety Eight Pesos and 42/100 (Php109,698.42) for various objects of expenditures;

b) Appropriation Ordinance No. 2022 – 001 of Barangay Sambaludan, entitled: “An Ordinance Authorizing Supplemental Budget No. 001, Series of 2022 involving the amount of One Hundred Twenty Five Thousand Pesos (Php125,000.00) and Appropriating the Necessary Funds for the Purpose;

c) Appropriation Ordinance No. 2022 – 001 of Barangay Sta. Rita, entitled: “An Ordinance Appropriating the Amount of Six Hundred Seventy Three Thousand Two Hundred Sixty Eight Pesos and 59/100 (Php673,268.59) which will be taken from Surplus 2021;

d) Appropriation Ordinance No. 2022 – 001 of Barangay Sta. Monica, entitled: “An Appropriation Ordinance Approving Supplemental Budget No. 2022 – 001 and appropriating the amount of Seven Hundred Forty Nine Thousand Five Hundred Sixty Four Pesos and 40/100 only (Php749,564.40) for Various Objects of Expenditures;

e) Appropriation Ordinance No. 2022 – 001 of Barangay Batuan Ilaya, entitled: “An Ordinance Authorizing Supplemental Budget No. 001, Series of 2022 Involving an Amount of One Hundred Fifty Five Thousand Fourteen Pesos and 51/100 (Php155,014.51) and Appropriating the Necessary Funds for the Purpose.

WHEREAS, as per review of the Committee, the Supplemental Budgets of 5 Barangays have the following attachments:

WHEREAS, the committee finds that these barangay Appropriation Ordinances conformed to budgeting laws and regulations.


