**RESOLUTION NO. 2025 – 145**

**DECLARING OPERATIVE IN THEIR ENTIRETY THE SK RESOLUTIONS OF BARANGAY CADINGLIAN, SAN NICOLAS, STA. RITA AND TUBURAN ALL IN OTON CONTAINING THEIR ANNUAL BUDGET FOR CY 2025.**

**WHEREAS**, the Joint Committee on Youth and Sports Development and Appropriation with the help of the Municipal Budget Officer reviewed SK resolutions containing the Annual Budget for C. Y. 2025 of Barangays Cadinglian, Sta. Rita, San Nicolas and Tuburan and enunciated in Committee Report NO. 2025- 54;

**WHEREAS**, the SK Resolutions containing the Annual Budget for Calendar Year of 2025 are the following:

**WHEREAS**, these four SK Resolutions are consistent with the priority programs, projects, and activities under section 20 of RA No. 10742 amended by DILG Memorandum Circular 2019-151. The budget may therefore be considered **OPERATIVE IN THEIR ENTIRETY**, provided that the following shall be complied with:

- a. That 10% SK fund should be programmed in accordance with priorities set for youth development program of the Sangguniang Kabataan with the Center of participation for health, education, economic empowerment, social inclusion and equity, peace-building and security, governance, active citizenship, environment, and global mobility.
- b. All programs, projects, and activities are based on the approved Annual Barangay Youth Development Plan (ABYIP); the amount provided for specific program, project, and activity in the annual budget is not higher to the amount provided in the ABYIP for the same program, project, and activity.
- c. Obligations and disbursement of the SK Annual Budget shall not exceed the amount authorized by the Sangguniang Kabataan, and subject to existing budgeting, accounting, and auditing rules and regulations.

**WHEREAS**, compliance with existing laws, rules and regulations of this budget shall be responsibility of the Chairman.

**WHEREAS**, the budget allocations of the four SK Resolutions appear to be well-distributed for various projects, fostering a holistic approach to youth engagement.






