**AUTHORIZING MAYOR SOFRONIO L. FUSIN, JR. TO ENTER INTO AND SIGN FOR AND ON BEHALF OF THE MUNICIPALITY OF OTON, ILOILO A MEMORANDUM OF AGREEMENT (MOA) WITH THE WORLD HOPE INTERNATIONAL – PHILIPPINES (WHI), AN INTERNATIONAL NGO, AS REPRESENTED BY FREDERICO CABREDO, FOR THE ONLINE SEXUAL ABUSE OR EXPLOITATION OF CHILDREN (OSAEC).**

**WHEREAS**, World Hope International – Philippines (WHI), an International NGO in the Philippines with an interest in developing and strengthening systems for the comprehensive care of survivors of Online Sexual Abuse or Exploitation of Children (OSAEC) in the Philippines;

**WHEREAS**, Local Government Unit of Oton serves as the principal agency for social welfare services within the Municipality of Oton, Iloilo, represented by Hon. Sofronio L. Fusin, Jr., Municipal Mayor;

**WHEREAS**, the parties in this agreement understand the severity of the issues of Online Sexual Abuse or Exploitation of Children (OSAEC) in the Philippines giving the rapidly increasing number of child victims. Both parties are also cognizant of the paramount importance of prevention and awareness campaigns and providing effective clinical care for the survivors of OSAEC to pave the way for healing and recovery;

**WHEREAS**, in achieving so, the parties recognize the need to implement prevention and awareness activities to increase the knowledge of the public about the issue and to empower them to take action. The parties recognize the need for specialized training for social workers and other care providers working with OSAEC survivors to equip them with knowledge and skills for the component delivery of services.




