ORDINANCE NO. 2025 – 495

**ORDINANCE PRESCRIBING THE REGULATIONS ON THE USE OF
VARIOUS AREAS AND STREETS AROUND THE PLAZA AND
MUNICIPAL HALL FOR THE USE OF CARNIVAL RELATIVE TO THE
CELEBRATION OF OTON TOWN FIESTA 2025.**

AS REQUESTED by the Local Chief Executive, **ON MOTION** of Hon. Rodolfo Z. Alconga, Jr., Chair Committee on Games and Amusement which was duly seconded by Hon. Josephus Ambrosius Renatus T. Escanlar

BE IT ORDAINED by this Sangguniang Bayan, that:

SECTION 1. INTRODUCTION.

- A. This Sanggunian has the power to regulate the use of streets, avenues, alleys, sidewalks, bridges and parks and other public places as provided under Section 447, Subsection (a) (5) of RA 7160 otherwise known as the Local Government Code of 1991.
- B. This ordinance is imperative since this local government needs to use temporarily a street, an alley and an open space for purposes of the town fiesta celebration.

SECTION 2. REGULATED ACTS.

From November 05, 2025 to December 10, 2025 the following shall be temporarily utilized:

1. Mabini Street (half lane only) - **from junction of C.M. Recto St. to RHU only**; It shall be a no entry street from J.C. Zulueta highway and other streets crossing it except for residents thereat.
2. The Open Space fronting Annex A and the Alley near the Municipal Hall shall be utilized by the carnival provided a fence be installed separating the carnival from the Pugad Lawin Mini Park. The opposite alley adjacent to the plaza shall be opened for public transport and parking, except in the evening from 6PM onwards, it shall be used for public functions/activities in the plaza. The circumference area of the Kogtong cup shall be free from any obstruction.
3. The street in front of the Parish Church shall be a two-way street and no vendors/kiosks allowed thereat.
4. The ingress and egress of Municipal Health Center and Parking spaces of TAGBITODA and CAMBITODA shall be free from obstruction.
5. The Poblacion West Trisikad terminal shall be beside the Oton Gymnasium.

SECTION 3. ADMINISTRATIVE PROVISIONS.

- A. There shall be PNP personnel and Traffic Aides assigned to man the above described areas for direction and temporary routing of all passing vehicles based on the traffic map/parade route. An area for the Help Desk shall be established to be manned by the Oton PNP with Brgy. Tanods and CSOs –Force Multipliers;
- B. The MDRRMO in coordination with the PNP shall provide proper road signs for the direction and convenience of the motorists and general public.
- C. Alternative Routes. Vehicles going to C.M Recto Street may pass General Luna Street or J.C Zulueta Street passing through front or back of the Parish church, or other intersecting streets to C.M. Recto Street.
- D. The GSO and MENRO shall ensure proper Solid Waste Management and Cleanliness of the area including the Toilets and Portalets;
- E. Illegal games shall be prohibited; Students and minors especially during class hours are not allowed to play games.
- F. Carnival Operation shall be until 12 midnight with regulations on noise pollution. All Ordinances related to littering, smoking, urinating, topless, vandalism and curfew shall be observed.

SECTION 4. REPEALING CLAUSE – All ordinances inconsistent with this ordinance are hereby repealed or amended accordingly.


SECTION 5. SEPARABILITY CLAUSE – If any provision of this ordinance is declared unconstitutional or inoperative, the other provisions not so declared shall remain in force and effect.

SECTION 6. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval of the Local Chief Executive.

SECTION 7. COPIES. This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; Barangays Poblacion South, Poblacion West, and Poblacion North; Poblacion East, 37 Barangays, MDRRMO, MBO, MTO, MOBO, OFTODA, Trisikad Assn., Oton Parish Church, GSO; MPDO for information and guidance and the Sangguniang Panlalawigan of Iloilo for review

UNANIMOUSLY APPROVED.


